Participation in Kidz Fest as a vendor is only \$35 as long as your booth provides an approved fun, interactive, or educational activity for children and their families to enjoy. Examples include crafts, face painting, balloon twisting, Lego building, etc. Raffles, giveaways and spinning wheels are not considered an activity or entertainment. Contact Vicki (info below) to brainstorm ideas if necessary. You may choose to rent a game or activity from the same rental company we are using and not have to pay a delivery charge. Check <https://recordahit.com> for options and pricing. Certain entertainment may require a Certificate of Insurance (\$1 mill). Electricity is not guaranteed and should be requested before renting an item.

If you are a vendor with items for sale, or you will not be providing entertainment at your booth, you will be charged a \$300 vendor fee.

All vendors that provide food are required to provide a **Certificate of Liability Insurance naming Joliet City Center Partnership, LLC and Will County as additional insureds**. This information must be provided prior to the event in order to reserve your spot at Kidz Fest. If you are providing food items, a Will County Health Department Permit is required. In order to avoid a late fee, all Health Department permits must be obtained no later than 1 week prior to the event.
